



How to play:

Forward your completed application by email funddev@gss.org.

You can increase your chances of winning by purchasing additional entries.

Rule of play:

- a) Entry is open to all employees of The Good Samaritan Society in Alberta.
- b) Must be a current resident of Alberta and over 18 years of age. Persons under the age of 18 years are not eligible to enter.
- c) This is a 50/50 lottery (50 percent of cash goes to the winner, 50 percent is collected as donations by The Good Samaritan Society).
- d) Minimum purchase price of entry is \$10. No refunds will be given.
- e) A minimum of 50% of tickets need to be sold before requesting a draw date extension or canceling the raffle through Alberta Gaming, Liquor and Cannabis.
- f) One winner is drawn in The Good Samaritan Society at 12 p.m. noon MST every Wednesday after payday. If a draw date falls on a statutory holiday the draw will be made on the business day immediately following.
- g) All winners are notified by email or by telephone. All employees of The Good Samaritan Society in Alberta are also notified.
- h) Prizes are paid by cheque and sent to the winner by mail or inter-office mail from The Good Samaritan Society.
- i) If a participant has a concern with the lottery they may contact Fund Development at funddev@gss.org or 780-431-3757.

How will draws take place?

The Draw will be determined by Random Number Generator every Wednesday after payday, unless there is a third pay period in the month, in which case there is no draw.

Please note that lottery participation is not considered a donation by the Canada Revenue Agency and is therefore not eligible for a tax receipt.
